A very brief summary of the discussion at the Joint PCC meeting to look at effective structures held on 11th March 2023

- The option of two "united PCCs" seems to be the most beneficial. In our case, three parishes (Priors Marston, Priors Hardwick & Wormleighton // Napton, Lower Shuckburgh & Stockton) would become one PCC, inheriting all the legal responsibilities of the predecessor parishes.
- Each existing parish would be represented on the united PCC with "due representation from each place". Several options could be explored there is room for flexibility.
- There would still need to be some form of delegated decision-making to each parish, eg around general maintenance of the building and setting up for church services. The role of the united parish would not be dissimilar to the work of the current Group Council but it would become a *legal* body, holding responsibility for the buildings and for worship. The number of small committees may not reduce but there would be a better joined-up decision-making process.
- One of the obstacles is likely to be around finance. There would be one set of accounts with one treasurer. Money that has been given to a previous parish for a specific use would be held in a "restricted" fund, with other gifts and donations being put into the main account to meet general running costs. It was noted that the scheme would benefit from economies of scale (eg some elements of church insurance could be shared) and if finance is an issue, pooling resources makes sense "there is more we can do together than separately."
- There were concerns about a loss of local identity but it was felt that this was not likely to happen because individuals remain part of their local village. The Offchurch group found that people remained committed to running their local church.
- It was acknowledged that there could still be difficulties appointing officers and churchwardens but surely less of a problem than finding 12 wardens and six sets of officers! There would need to be a clear job description for each role. This is about re-arranging *how* the work is done.
- There are still lots of questions to be answered and details to be worked out but it would seem sensible to take the process forward to the next stage and see where it leads. It is a lengthy and legal process. Establishing a "Pastoral Scheme" would require consultation with the wider congregation and community and could take from 9 months to a year to put in place.
- And, whichever route we take, it will not resolve the problem of finding people willing to be churchwardens or PCC officers or take away the difficulties of maintaining six ancient buildings.
